1. PURPOSE OF AGREEMENT

5. AMENDMENTS

This Memorandum of Understanding may be amended by a written agreement signed by the Head of Institutions of the college.

In the event of any unforeseen incident during collaborative activities in either country both universities agree to negotiate a mutually acceptable solution.

Should any disagreement arise of the application, interpretation or implementation of this agreement, the college shall endeavor to exercise best efforts to negotiate their differences.

6. TERMS

The parties agree not to discriminate on the basis of religion, race, and creed, nationality of ethnic origin, sex, age handicap, political affiliation, sexual orientation, disability or status as a veteran.

None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising marketing, endorsement or any other purpose without specific prior written consent of an authorized representative of the other party and the each such use.

This MOU is without any legal & financial liabilities to any party.

MOU be treated as Null and Void in case of any types of differences between the both.

Duration

This MOU shall be in effect for a period of 05 Years from (25/08/2023) to (25/08/2028) any activity decided will be in between the mentioned period.
